**Call the San Benito County Fair at (831) 628-3421 to make reservations and arrange for payment.**

**Fees are \$35/night for hookups and \$20/night for dry camping.**

The vendor's tent will be located in front of the Grandstand. It is expected that your booth will be open and manned during Show hours, Friday, Saturday and Sunday. Set-up on Friday any time after 8:00 a.m. Booth to be open for business by 3:00 p.m. Friday. Vendor tent will be locked down and **security provided Friday and Saturday nights.**

**COST:**        **\$175** for a booth 10 x 10 with one 4 x 8 table and two chairs

**\$350** for a booth 10 x 20 with two 4 x 8 tables and four chairs

An additional **\$25** per vendor covers liability insurance if you don't have it.

**If power is needed, vendors must bring their own 150 ft. to 200 ft. extension cord.**
